FINANCIALS

- 1. <u>February 28, 2021 Financials</u>: The Association fiscal year ends on March 31. Georgia reviewed the financial statements for the period ending February 28, 2022. She provided a detailed explanation of the items and answered questions from the Membership.
- 2. <u>Budget Ratification</u>: Georgia reviewed the Board approved operating budget for the 2022/2023 fiscal year in detail. She explained each individual line item and answered questions from the Membership. In accordance with Colorado House Bill 18-1342 which became effective July 1, 2018 and requires all Colorado Common Interest Communities Incorporated before July 1, 1992 to comply with a provision of the Colorado Common Interest Ownership Act (CCIOA) and allows a majority of the Owners in a Common Interest Community to veto a budget proposed by the Executive Board, a majority of the Unit Owners did not veto the Budget and it was automatically ratified. Please refer to the budget regarding the assessment increase that takes place on April 1, 2022.
- 3. <u>IRS Revenue Ruling 70-604</u>: This ruling allows the Association to apply excess membership income over membership expenses for the year-end to the subsequent tax year for common reserves. *A motion was made and seconded to exercise this ruling. The motion carried unanimously.*
