The Board of Managers introduced themselves and introduced Gwen Ballard with HillStar Management and Georgia Olave with Olave Bookkeeping.

Minutes Approval: *A motion was made and seconded to approve the minutes from the June 7, 2022 Annual Meeting as written. The motion carried unanimously; none were opposed.*

Financials: Olave Bookkeeping reported on various details of the financial statements for the fiscal year-ending March 31, 2023. Spinnaker was \$68,594.36 unfavorable to budget for revenue, due to less rentals than anticipated. On the expense side, Spinnaker was \$53,619.29 over budget, a direct correlation to the rental revenue. Net operating income was unfavorable to budget by \$115,689.30.

Board of Management Election: *With three (3) positions open and only three (3) candidates, a motion was made and seconded to appoint Sue Bauer, Skip Spensley and Allen Kirsh to the Board of Managers by acclamation for a 3-year term. The motion carried unanimously.*

Owner Forum: The Board and Management answered questions from the Owners in attendance.

Adjournment: The meeting was adjourned at 7:02 p.m.
